# NATIONAL AUDIT TOOL FOR AMUSEMENT DEVICES

## Guidance for completing the National Audit tool.

- This audit tool is specifically for regulatory inspections by authorised officers of Work Health and Safety authorities. However it may be used in part or full by others, e.g. device operators preparing for an audit. Note: An audit using this tool is not a substitute for an annual inspection.
- The national audit tool provides 2 options,
  - a full audit, i.e. logbooks, maintenance records and site verification of set up and operation; complete sections A, B & C (in no specified order), or
  - a site set-up audit for the show set-up being completed; complete sections A & D only.
- WHS inspectors should check the National Register Spread Sheet (available from WHSQ Engineering Unit email [engineering@oir.qld.gov.au](mailto:engineering@oir.qld.gov.au)) and their jurisdiction's register/database for outstanding notices/issues prior to auditing.
- If the WHS inspector is auditing a recently audited ride (e.g. within the last 2 months, this depends on jurisdictional requirements and guidance) and no issues were identified, the inspector may opt to only focus on site issues related to the set-up without the need to complete all elements of section D for site set-up.
- If there are elements of the audit tool that do not apply OR are not assessed mark those elements as N/A, i.e. not applicable or not assessed, and please include a short comment.
- Where complex issues are identified seek guidance from your amusement devices support unit (E.g. Engineering Unit in WHSQ). For example; enforcement of the design registration regulations or rider restraint assessment using the new Type 1, Type 2, etc, restraint assessment in AS 3533.
- To ensure subsequent audits cover any outstanding issues please use the summary sheet or leave your contact details with the operator so you can be contacted if an inspector needs clarification of any past audit issues.
- When complete, record the data as required in your jurisdiction and notify workplace health and safety Qld of details re notices issued. Contact details are at the end of each audit section and this data will be included on the National Register Spread-Sheet.

Note: To accommodate the differences in legislation, some jurisdiction will utilise a slightly modified version of this audit tool.
