



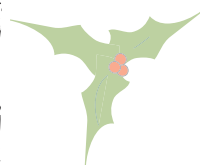

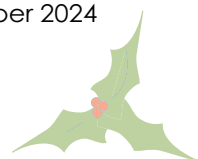

Notice is given that Council of the City of Gold Coast (Council), at a Special Council Meeting held on 19 November 2024 resolved to repeal *Temporary Local Planning Instrument No. 1 of 2024 – Arundel Hills* (TLPI 01/2024 – Arundel Hills) in accordance with section 24(1) of the *Planning Act 2016*.

Pursuant to section 24(2) of the *Planning Act 2016*, prior to making the resolution, Council received written approval from the Deputy Premier, Minister for State Development, Infrastructure and Planning and Minister for Industrial Relations to repeal TLPI 01/2024 – Arundel Hills.

TLPI 01/2024 – Arundel Hills is repealed by the resolution and ceases to have effect.

Short Title

1. This order in council may be cited as the *Administrative Arrangements Order (No. 3) 2024*.

Administrative Arrangements

2. (1) The public business of the State is distributed among Ministers as set out in the Schedule.

(2) Each Minister is to administer the matters set out in the Schedule next to the Minister's title as follows:

- (a) the matters connected with the public business of the State listed under the heading 'Principal Ministerial Responsibilities';
- (b) the legislation listed under the heading 'Acts Administered'; and
- (c) the administrative units listed under the heading 'Administrative Units'.

(3) Information in the Schedule under the heading 'Responsible Heads' is included for information only and does not form part of this order.

Repeal of earlier Administrative Arrangements

3. The *Administrative Arrangements Order (No. 2) 2024* is repealed.

Commencement

4. This order commences on the day it is published in the Gazette.

1. This notice may be cited as the *Taking of Easement Notice EAS 2993 (16) (2024)*

Easement taken [ss.6 and 15 (d) of the Act]

2. The easement described in Schedule 2 is taken by Northern SEQ Distributor-Retailer Authority (trading as Unitywater) for works for the reticulation of water supply and vests in Northern SEQ Distributor-Retailer Authority (trading as Unitywater) on and from 22 November 2024.

Rights and obligations

3. That the rights and obligations conferred and imposed by the Easement include the matters set out in Schedule 1.

SCHEDULE 1**1. DEFINITIONS AND INTERPRETATION****1.1 Definitions**

In this Easement unless the context or subject matter require otherwise:

- (a) Easement Land means that part of the land over which this easement is taken;
- (b) Matter means buildings, structures or other materials or things erected, placed, found or installed upon the Easement Land and includes trees and plants within the Easement Land;
- (c) Owner means any person who has an estate, interest, right, power or privilege in, over, or in relation to the land subject to the Easement Land and that person's administrators, assignees and successors; and
- (d) **Relevant Works** means:
 - (i) where the purpose of this Easement is "Sewerage": sewer(s) and/or pipeline(s) for the purpose of conveying sewerage and all kinds of waste through, across or under the Easement Land together with manholes, stopcocks and all other usual or necessary fittings and attachments (including pumps and/or pump stations where required) as well as works for the protection and/or support of such things; and
 - (ii) where the purpose of this Easement is "Water Supply": water reticulation mains and/or pipelines for the purpose of conveying water supplied by Unitywater through, across or under the Easement Land together with manholes, stopcocks, meters, pressure control devices, pumps and/or pump stations, water reservoirs, and all other usual or necessary fittings and attachments as well as works for the protection and/or support of all such things; and
- (e) **Unitywater** means:
 - (i) The Northern SEQ Distributor-Retailer Authority (trading as Unitywater) established under section 8 of the *South-East Queensland Water (Distribution and Retail Restructuring) Act 2009* and its assignees and successors; and
 - (ii) If the context permits, Authorised Persons.

1.2 Interpretation

In this Easement:

- (a) a reference to a statute includes Orders in Council, Proclamations, Regulations, Rules, Local Laws and Ordinances made under the statute and any

statute amending, consolidation or replacing the statute;

- (b) headings have been included for ease of reference and guidance and this Easement is to be construed without reference to them;
- (c) the singular number includes the plural and vice versa;
- (d) words importing a masculine gender includes all other genders; and
- (e) words importing persons include companies and corporations and vice versa;
- (f) if a covenant contained in this Easement is or becomes invalid or unenforceable, the remaining covenants contained in this Easement remain in full force and effect; and
- (g) if a party to this Easement comprises two or more legal entities, the covenants contained in this Easement bind each of them jointly and severally.

2. RIGHTS OF UNITYWATER**2.1 Access**

Where the purpose of this Easement includes Access, the following will apply:

The Owner grants to Unitywater the full and free right and liberty at all times, after the date of this Easement, to enter upon and remain, pass and repass on and over the Easement Land at will and as often as the occasion requires, with employees, agents and contractors and other persons authorised by Unitywater and with or without vehicles, plant and equipment of any description whatsoever.

2.2 Sewerage or Water Supply or Both

Where the purpose of this Easement includes Sewerage or Water Supply or both the following will apply

The Owner grants Unitywater the full and free right and liberty at all times, after the date of this Easement, to enter upon the Easement Land for the purposes of constructing and thereafter forever using and maintaining the Relevant Works as it shall from time to time think fit and in so doing, Unitywater by its employees, agents and other persons authorised by Unitywater has the right to:

- (a) construct, install, extend, deepen, widen, cleanse, add to, remove, inspect, maintain and repair the Relevant Works and when and where thought fit by Unitywater to remove and replace the Relevant Works with new Relevant Works (whether of a similar nature to those replaced or not);
- (b) to change the size and number of any pipes which form part of the Relevant Works;
- (c) dig into, sink shafts in, and erect scaffolding upon the Easement Land and to open and break up the soil of the Easement Land or any part of the Easement Land including its sub-surface;
- (d) remove and dispose of spoil created as a consequence of exercising its rights hereunder;
- (e) clear and keep clear the Easement Land by any means or method and to cut and remove timber, trees and undergrowth from the Easement Land and to burn off such timber, trees and undergrowth;
- (f) construct and maintain on the Easement Land such access tracks, gates and appurtenant works as it considers necessary;
- (g) enter upon and remain, pass and repass on and over the Easement Land for all or any of the purposes aforesaid with or without vehicles, plant and equipment of any description whatsoever;
- (h) enter and exit to and from the Easement Land over such part or parts of the Owner's land adjoining or adjacent to the Easement Land as is reasonably required by Unitywater and Unitywater shall consider most convenient or necessary for the purpose of passing between the Easement Land and the most convenient

point of entry to or exit from the Owner's land (whether adjoining a constructed road or not);

- (i) do such other works and things through, across, in or under the Easement Land as are incidental to the proper exercise of the rights granted to Unitywater under this Easement; and
- (j) use such part or parts of the Owner's land immediately adjacent to or adjoining either side of the Easement Land as may be reasonably required by Unitywater for the proper exercise of the rights granted to Unitywater under this Easement.

3. **PROPERTY IN RELEVANT WORKS**

The Relevant Works are and remain the property of Unitywater notwithstanding any actual or apparent affixing to the Easement Land. Unitywater shall be solely responsible, for the operation and maintenance of all Relevant Works.

4. **FENCING**

4.1 **Removal**

For the purpose of gaining access to the Easement Land, Unitywater may demolish or break open any fencing on or adjacent to the Easement Land. However, if livestock are contained within the fenced area, Unitywater must give reasonable notice to the Owner to enable the Owner to secure the livestock.

4.2 **Reinstatement**

Unitywater must either:

- (a) reinstate all fences (other than a fence erected in contravention of Clause 5) damaged by Unitywater in the exercise and performance of any of the rights and liberties granted to Unitywater under this Easement; or
- (b) if the fences are not reinstated, install a gate using materials and employing workmanship which is not less than the quality of the materials and workmanship in the existing fence. The gate installed pursuant to this subclause becomes the property of the owner of the fence in which the gate is installed and after installation shall be maintained by the owner.

5. **NO STRUCTURES ON THE EASEMENT LAND**

The Owner must not at any time without the express written permission of Unitywater (which must not be unreasonably withheld):

- (a) erect any buildings or structures (other than fences) upon the Easement Land or any part of it;
- (b) permit the Easement Land or any part of it to be used in such a way as to obstruct or interfere with the Relevant Works and/or the proper and effective use of the Relevant Works by Unitywater;
- (c) install concrete, bitumen or other pavement or driveways (except residential driveways) on the Easement Land or gardens or landscaping involving concrete, brick or other permanent materials; or
- (d) remove or stockpile or permit the removal or stockpiling of any soil, sand, gravel or other substance or material on the Easement Land or construct any roads, dam walls or other earthworks on the Easement Land which would in any way obstruct or interfere with the Relevant Works and/or the proper and effective use of the Relevant Works by Unitywater.

6. **DAMAGE TO STRUCTURES**

- (a) Unitywater acting reasonably at all times and complying with all relevant laws, will determine how and in what manner the rights granted to Unitywater under this Easement are exercised.
- (b) Unitywater must not wilfully damage or destroy any Matter to any extent greater than is reasonably

necessary in order to exercise its rights under this Easement but:

- (i) Unitywater is not otherwise responsible for any damage to or destruction of any Matter in the course of the exercise by Unitywater of its rights under this Easement; and
- (ii) subject to Clause 4, Unitywater is not under any obligation to reinstate or repair any Matter damaged or destroyed in consequence of the exercise by Unitywater of its rights under this Easement and its only obligation where such Matter has been so damaged or destroyed is to leave the Easement Land in as clean and tidy state as practicable having regard to the nature of the Matter which has been damaged or destroyed and the work which it has done; and
- (iii) Unitywater is not in any event responsible for any inconvenience or disturbance to the Owner or occupiers of the Easement Land arising out of the exercise by Unitywater of its rights under this Easement.

7. **REMOVAL OF UNAUTHORISED STRUCTURES**

If a Matter is erected, placed, found or installed upon the Easement Land in contravention of Clause 5, Unitywater may, in addition to any other remedies and after having first given the Owner reasonable notice of its intention to invoke this clause, enter upon the Easement Land and remove or demolish the Matter and, if it does so:

- (a) it may dispose of the Matter or any resultant demolition materials in such manner as it sees fit without being liable to account to the Owner therefore (except as provided in subclause (b) of this clause); and
- (b) it may recover, in any Court of competent jurisdiction, costs actually incurred by it in taking that action (including internal wage and salary costs) less any moneys actually received by it as a result of disposing of the Matter or any resultant demolition materials.

8. **PROTECTION OF RELEVANT WORKS**

The Owner will not do any act or make any omission which will jeopardise or prejudicially affect the safety or reliable working of any Relevant Works.

9. **RATES AND CHARGES**

The Owner is responsible for all local authority rates and assessments and lawful charges in relation to the Easement Land.

10. **FURTHER ASSURANCES**

The benefit and burden of this Easement shall pass with and bind the Easement Land so as to enure to and bind all persons deriving title thereto from and under the Owner and Unitywater respectively and the Owner, whenever required by Unitywater or the person or persons for the time being entitled to the benefit of this Easement, must do all such things and give all such assurances as are reasonably required for the proper and effective carrying into effect of the rights conferred under this Easement but not so as to render the Owner liable to be called upon to contribute towards the maintenance and upkeep of the Relevant Works.

11. **SPECIAL COVENANTS FOR STATE RESERVE LAND**

- (a) The following clauses are in addition to or replace where noted those set out above and will form part of the covenants of this Easement when any land is designated as a "Reserve" in accordance with the *Land Act 1994* (as amended from time to time).
- (b) In this clause:

“Minister” means the Minister administering the *Land Act 1994* (as amended from time to time); and “Trustee” means the relevant Trustee of the State Reserved Land.

(c) **Reinstatement of fencing**

Clause 4.2 of this Easement is deleted and replaced with the following:

Unitywater must either:

- (a) *Reinstate all fences damaged by it in the exercise of any of its rights granted herein; and*
- (b) *In lieu of reinstating any such fence, install a gate the quality and materials of workmanship of which must be not less than the quality and materials of workmanship of the existing fence.*

(d) **Removal of Unauthorised structures etc**

Clause 7 of this Easement is omitted and replaced with the following:

If anything is erected, placed, found or installed upon the Easement Land in contravention of Clause 5, Unitywater may, in addition to any other remedies, and having given the Owner reasonable notice of its intention to invoke this clause, enter Easement Land and remove or demolish the Matter. If it does so it may dispose of the Matter or any resultant demolition materials in such manner as it sees fit without being liable.

(e) **Removal of Trees**

Unitywater must not cut or remove timber or tress from the Easement Land without first giving reasonable notice to the Owner and obtaining all necessary permits. Such notice will not be required under this clause in the event that there is an actual or potential danger to persons or property or there is any interference or jeopardy to the supply of the Relevant Works.

(f) **Removal of Assets upon termination of easement**

Under the *Land Act 1994*, an easement over a reserve ends when the dedication of reserve is revoked unless a written approval is provided by the Minister that the easement may continue over unallocated State Land when the dedication of reserve is revoked.

Upon termination of the Easement, Unitywater

- (i.) must ensure that the Easement Land is left in a safe and stable condition to the satisfaction of the Minister; and
- (ii.) will unless directed by the Minister otherwise, at its own cost and expense, remove all of the Relevant Works from the Easement Land; and
- (iii.) will remove, at its own cost and expense, all of the Relevant Works from the Easement Land that may cause contamination or environmental harm to the Easement Land as defined by the *Environmental Protection Act 1994* or similar legislation.

(g) **Indemnity and Risk**

The following clauses will apply for the duration of the Easement and will continue to apply during the periods of rehabilitation and any removal of the Relevant Works under clause 11 (f):

(i.) **Indemnity**

- a. Unitywater indemnifies and agrees to keep indemnified the Minister, the State of Queensland, Trustee and

Owner (the “indemnified parties”) against all actions, suits, proceedings, claims, demands, costs, losses, damages and expenses (“Claims”) arising out of or in any way connected to or resulting from the granting of this Easement to Unitywater or which is connected to or resulting from Unitywater’s use and occupation of the Easement Land (all of which are referred to as “the indemnified acts or omissions”) save to the extent that the claim arises as a result of any negligent act or omission of the indemnified parties, however, any negligent act or omission or one of the indemnified parties does not negate the indemnity to any other indemnified parties.

- b. Unitywater hereby releases and discharges the indemnified parties from any Claim relating to the indemnified acts or omissions which may be made against the indemnified parties, save to the extent that the Claim arises as a result of any negligent act or omission of the indemnified parties, however, any negligent act or omission of one of the indemnified parties does not negate the release and discharge in favour of any of the other indemnified parties.

(ii.) **Public Risk**

- a. Unitywater must effect a public liability insurance policy with an insurer authorised under the *Insurance Act 1973* (Commonwealth) or, in any other case, to the satisfaction of the Minister naming Unitywater as the insured covering legal liability for any loss of, or damage to any property and for the injury (including death) to any person arising out of anything done or omitted on or about the easement land or any improvements thereon and against all claims, demands, proceedings, costs, charges and expenses whatsoever in respect thereof subject to the terms and conditions of the insurance policy.

- b. Such policy must:

- (a) be for an amount not less than \$20,000,000.00 (Twenty Million dollars) in respect of all claims arising out of a single event or such higher amounts as the Minister may reasonably require; and
- (b) be effected on a “claims occurring” basis so that any claim made by Unitywater under the policy after expiration of the period of policy cover but relating to an event occurring during the currency of the policy will be covered by the policy subject to the claim meeting the policy’s other terms and conditions; and
- (c) be maintained at all times during the currency of the Easement,

and upon receipt of any Notice of Cancellation, Unitywater must immediately effect another public liability insurance policy in accordance with the provisions of this Clause 11(g) (ii).

- c. Unitywater must also provide a certificate of currency within 14 days of a request by the Owner who may only make such request once a year.
 - d. Unitywater must, as soon as practicable, inform the Minister and Owner in writing, of the occurrence of any event that Unitywater considers is likely to give rise to a claim under the policy of insurance effected and must ensure that the Minter and Owner are kept fully informed of subsequent actions and developments concerning the claim.
- (h) **Power of Attorney**
Whilst the Easement Land remains unallocated State Land or is dedicated as a Reserve pursuant to the *Land Act 1994* as amended from time to time or is registered solely in the name of the State of Queensland, Unitywater irrevocably appoints in so far as it is legally able to the State of Queensland the true and lawful attorney of Unitywater enabling the attorney to do all such things as the attorney may consider necessary or desirable to effect a surrender of this easement upon the default by Unitywater of any condition, covenant or clause of this easement provided however that the State of Queensland may only exercise its right to surrender the easement under this clause if:
- (i.) Unitywater has breached a condition, covenant or clause of this easement; and
 - (ii.) the State of Queensland has given written notice to the breach of Unitywater; and
 - (iii.) the State of Queensland has allowed Unitywater 90 days from the date of receipt of the notice to remedy the breach; and
 - (iv.) Unitywater has not remedied the breach by the expiration of that 90 days.

Annual review

Same-day accommodation (daily)

Stand-alone day surgery facilities will be paid using the same-day services table.

Prior approval for any elective hospitalisation **must** be obtained from the insurer **prior** to the patient admission.

Accident and emergency attendance

Accident and emergency (A&E) attendance for the immediate treatment of a work-related injury is not considered to be an elective hospitalisation. The private A&E facility must operate under the licence of the private hospital facility to enable alignment of invoicing under item **400599**. However, payment of expenses associated with an A&E attendance will only be paid where there is an accepted claim for the relevant injury treated.

Overnight accommodation (daily fee)

Approval for any elective hospitalisation **must** be obtained from the insurer **prior** to the patient admission.

The admission must be:

- required because of the work-related injury or illness
- reasonable, necessary, or appropriate in the circumstances
- clinically justified, safe and effective.

Multiple services

Where more than one service⁴ is provided in a single theatre session, the theatre charge is:

- a) 100% of the service with the highest theatre charge plus
- b) 50% of the service with the next highest theatre charge plus
- c) 25% of each of the other services provided.

All specialist consultations, surgical assistant charges, allied health services or diagnostic (including pathology) investigations completed during a surgical admission are to be invoiced as per the relevant table of costs by the relevant service provider. Special access robotic devices

Only in exceptional circumstances will additional fees be paid for special access robotic devices. Detailed clinical evidence (e.g., letter outlining the justification of use and applicable fees) from the hospital that the item is reasonably necessary for the appropriate management and treatment of the work-related injury will be required. **Prior approval** must be provided, in writing, by the insurer. In circumstances where the insurer has given prior approval for the billing of special access robotic devices, item code **400507** is to be used.

Exigent clinical circumstance

Where exigent clinical circumstances exist and special access robotic devices are required immediately to enable the provision of lifesaving treatment, prior approval from the insurer is **not required**. The insurer may request clinical justification to understand the need for the special access robotic device/s in these circumstances.

All invoicing for medical devices or human tissue product must include the relevant [Department of Health Prescribed List](#) billing code.

For items which may be **removed** from the prescribed list as part of the staged federal Department of Health Prostheses List reforms, reimbursement for use of these items is subject to pre-approval from the insurer. The insurer may request clinical justification to understand the use of the removed item in these circumstances. The request must also be accompanied by a supplier quote / invoice.

Medical devices or human tissue products that are opened during procedures and not used will not be paid for unless there are **valid clinical circumstances** preventing successful implantation of such devices or products. All devices or products paid will need to be supported by the operation record and / or device / product stickers on the nurse's Intraoperative Report / Count Record / Implant Record or by a submission from the treating specialist detailing the clinical circumstances that prevented the successful implantation of the initial device or product.

Insurers may request a copy of the nurse's Intraoperative Report / Count Record / Implant Record relating to workers' compensation admissions from time to time.

Provision of health records (at insurer request only)

Patient health records refer to all records relating to the workers' compensation claim including file notes, results of relevant tests and operation notes.

Patient health records are to be provided within **fourteen (14) days of request**.

Temporary assistive devices*

Only temporary assistive devices provided at **discharge** may be charged separately and must be billed using item code **400508**. The insurer will only fund temporary assistive devices provided at discharge that relate to the hospital admission.

Hospital in the Home (HITH) services are to be billed as per the relevant Medical and/or Allied Health Table of Costs. All the relevant Table of Costs can be located [here](#).

Rehabilitation in the Home (RITH)

Mental health programs (daily fee)

Approval for any elective hospitalisation must be obtained from the insurer **prior** to the patient admission. Requests must be made using the 'Request for Specialised Program' form (FM303).

Inpatient admission – service provision

Specialised overnight admitted patient mental health care (also referred to as specialised psychiatric care) takes place within a designated mental health ward / unit, which is staffed by a health professional with specialist mental health qualifications or training, and have as their principal function, the treatment and care of patients affected by mental illness⁵.

The program is managed by a multi-disciplinary team including a medical director and consultant psychiatrist (i.e., Fellow of the Royal Australian and New Zealand College of Psychiatrists). They are defined programs with targeted service provision. Specific outcome goals are to be clearly defined and measured during admission. The program includes physiotherapy, occupational therapy, clinical psychology, group education sessions, graded gym sessions, relaxation sessions, case conferences, and discharge planning.

Additional costs during admission

All specialist consultations or diagnostic (including pathology) investigations completed during an inpatient admission are to be invoiced as per the relevant table of costs by the relevant service provider. Further information regarding the scheduled fees payable on a workers' compensation claim can be found on our [website](#).

Mental health treatments

Electroconvulsive Therapy (ECT)

For every instance of 14224 that is charged by the medical practitioner providing the service (according to the Medical Table of Costs) an invoice can be provided for the appropriate banding rate for the level of sedation and the appropriate accommodation charge if admitted as a day patient or overnight.

ECT is to be administered as per the recommended [Queensland Health guideline](#).

Repetitive Transcranial Magnetic Stimulation (rTMS)

For every instance of rTMS that is charged by the medical practitioner providing the service (items **14216**, **14217**, **14219**, **14220** according to the Medical Table of Costs) an invoice can be provided for the appropriate banding rate for the level of sedation and the appropriate accommodation charge if admitted as a day patient or overnight.

Day patient – service provision

A day patient program is usually available to provide ongoing support and care to patients after discharge from treatment as inpatients or in circumstances where an inpatient admission has not been possible / available. It is managed by a multi-disciplinary team of healthcare professionals and is **tailored** to the individual needs of the patient. It can include specialised therapy modules including cognitive behavioural therapy, relaxation, coping skills, and anxiety management. A day patient program should include a gradual return to work focus.

Patient outcome data

Insurers may request a copy of the patient outcome data relating to workers' compensation admissions for mental health programs.

Rehabilitation programs (daily fee)

Approval for any elective hospitalisation must be obtained from the insurer **prior** to the patient admission. Requests must be made using the 'Request for Specialised Program' form (FM303).

Inpatient admission – service provision

Rehabilitation programs involve referral and assessment by the coordinator of the program. The assessment is undertaken by a rehabilitation physician (i.e., Fellow of the Australasian Faculty of Rehabilitation Medicine, The Royal Australasian College of Physicians). In addition, the rehabilitation physician will oversee the patient's participation in the program. They are defined programs with targeted service provision. Specific outcome goals are to be clearly defined and measured during admission. The program includes physiotherapy, aquatic therapy, occupational therapy, psychology (as appropriate), speech therapy (if relevant), case conferences, and discharge planning.

Additional costs during admission

All specialist consultations or diagnostic (including pathology) investigations completed during an inpatient admission are to be invoiced as per the relevant table of costs by the relevant service provider. Further information regarding the scheduled fees payable on a workers' compensation claim can be found on our [website](#).

Day patient – service provision

A day patient program is usually available to provide ongoing support and care to patients after discharge from treatment as inpatients or in circumstances where an inpatient admission has not been possible / available. Inpatient admission – service provision

Pain programs involve referral and assessment by the coordinator of the program. The assessment is undertaken by a pain physician (i.e., Fellow of the Faculty of Pain Medicine, Australian and New Zealand College of Anaesthetists). In addition, the pain physician will oversee the patient's participation in the program. They are defined programs with targeted service provision. Specific outcome goals are to be clearly defined and measured during admission. The program includes physiotherapy, aquatic therapy, occupational therapy, clinical psychology, group education sessions, graded gym sessions, relaxation sessions, case conferences, and discharge planning.

Additional costs during admission

All specialist consultations or diagnostic (including pathology) investigations completed during an inpatient admission are to be invoiced as per the relevant table of costs by the relevant service provider. Further information regarding the scheduled fees payable on a workers' compensation claim can be found on our [website](#).

Day patient – Service provision

Inpatient admission – service provision

These programs provide the specialised treatment and care for patients with alcohol or drug dependency (including analgesics / narcotics / opiates and benzodiazepines). The program is managed by a multi-disciplinary team including a medical director and consultant psychiatrist or addiction specialist (i.e., Fellow of the Royal Australian and New Zealand College of Psychiatrists or Fellow of the Australasian Chapter of Addiction Medicine, Royal Australasian College of Physicians). Where required, the program involves the medically controlled, safe withdrawal of drugs or alcohol.

They are defined programs with targeted service provision. Specific outcome goals are to be clearly defined and measured during admission.

Additional costs during admission

All specialist consultations or diagnostic (including pathology) investigations completed during an inpatient admission are to be invoiced as per the relevant table of costs by the relevant service provider. Further information regarding the scheduled fees payable on a workers' compensation claim can be found on our [website](#).

Day patient – service provision

A day patient program is usually available to provide ongoing support and care to patients after discharge from treatment as inpatients or in circumstances where an inpatient admission has not been possible / available. It is managed by a multi-disciplinary team of healthcare professionals and is **tailored** to the individual needs of the patient. It can include specialised therapy modules including cognitive behavioural therapy, relaxation, coping skills, and (if relevant) post treatment medication management.

Patient outcome data

Insurers may request a copy of the patient outcome data relating to workers' compensation admissions for alcohol and other drug (AODs) programs.

Haematology and oncology

Approval for any elective hospitalisation must be obtained from the insurer **prior** to the patient admission.

Any haematology or oncology service delivered is to be invoiced as per:

1. The relevant PBS rate for the agent or drug must be billed using item no. **400595**.
2. Where an infusion pump is used for the delivery of the agent or drug, a fee of \$82 will be paid and must be billed using item no. **400597**. Infusion pumps are not considered to be a disposable or consumable, they are considered for the purposes of this document to be an approved device.
3. The relevant item code within the [Medical Items Table of Costs](#) for the parenteral chemotherapy.
4. The appropriate accommodation charge as relevant from the table below:

5. Any other patient care costs (not referenced in items 1-4 above) for workers undergoing haematology / oncology treatments, which may include (but are not limited to) scalp cooling treatments, oncology maintenance services, patient education sessions, stem cell storage must be billed using item no. **400600**.
6. Outpatient services, such as Evusheld or subcutaneous non-chemotherapy treatments (e.g., bisphosphonates), delivered to **immunocompromised patients only**, must be billed using item no. **400601**.

The treatment protocol is to be dictated by the relevant specialist team in relation to the accepted work-related injury.

Where a high cost, non-PBS drug is required to treat the work-related injury, a pharmacy estimate must be provided to the insurer for prior approval.

Agents or drugs include:

- alkylating agents
- nitrosoureas
- anti-metabolites
- plant alkaloids
- anti-tumour antibiotics
- hormonal agents
- biological response modifiers.

Additional costs during admission

All specialist consultations or diagnostic (including pathology) investigations completed during an inpatient admission are to be invoiced as per the relevant table of costs by the relevant service provider. Further information regarding the scheduled fees payable on a workers' compensation claim can be found on our [website](#).

Explanatory notes

Health literacy for patients

Health literacy is about how:

- a worker **accesses** the relevant information about their health and healthcare
- a worker **understands** information about their health and healthcare
- they **use** the information to make **informed decisions** about their healthcare.

WorkCover embraces to Australian Commission on Safety and Quality in Health Care position on [Health Literacy](#) and the [National Safety and Quality Health Service \(NSQHS\) Standards](#).

WorkCover expect all providers who deliver services to Queensland workers to:

- make it easy for the worker to know where to go, what to do and how to find what is needed to improve their health and wellbeing, including information about their diagnosis, prognosis, processes, likely outcomes of possible tests and treatments and how prevent further injuries or illnesses
- make it easy for the worker to make better decisions about their health, wellbeing, and health care
- make it easy for the worker to manage their own health care, including treatment and medications
- help the worker to contribute to more effective decision-making and action about their own health care
- work in partnership with the worker so the worker can made informed and effective decisions
- help the worker reduce the risk of harm to themselves by providing thorough information that they can understand.⁶

Theatre fees

The theatre fees include the costs of consumables and disposable items (refer to definition of consumables below).

Provision of high cost surgical, consumable, and disposable items during an admission requires pre-approval by the insurer. The insurer will not unreasonably withhold approval during an emergency, where the item is clinically required.

Only in exceptional circumstances will additional fees be paid for high cost surgical, consumable, and disposable items on provision of clinical evidence (e.g., letter outlining the justification of use) from the hospital that the item is reasonably necessary for the appropriate management and treatment of the work-related injury.

Exigent clinical circumstance

Where exigent clinical circumstances exist and a high cost surgical, consumable, and disposable is required immediately to enable the provision of lifesaving treatment, prior approval from the insurer is **not required**. The insurer may request clinical justification to understand the need for the provision of the high cost surgical, consumable, or disposable in these circumstances.

Pharmacy

Accommodation fees also **include** the cost of PBS pharmaceutical items provided during the admission. The insurer will only fund non-PBS pharmaceutical items where no PBS equivalent exists.

Provision of high-cost drugs during an admission requires pre-approval by the insurer. The insurer will require provision of clinical evidence (e.g., letter outlining the justification of use) from the hospital that the high-cost drug is reasonably necessary for the appropriate management and treatment of the work-related injury.

High-cost drugs do not have a formal definition in Australia. For the purposes of this table of costs, high cost drugs have been defined as those that are not:

- listed under the [Pharmaceutical Benefits Scheme](#)
- funded through the s100 program (Section 100 of the [National Health Act 1953](#)) and the Life Saving Drugs Program (LSDP).

Only pharmaceutical items provided at discharge may be charged separately and must be billed using item code **400596**. The insurer will only fund discharge medication that relates to the hospital admission.

Exigent clinical circumstance

Where exigent clinical circumstances exist and a high-cost drug is required immediately to enable the provision of lifesaving treatment, prior approval from the insurer is **not required**. The insurer may request clinical justification to understand the need for the provision of the high-cost drug in these circumstances.

Account and invoicing standards

If applicable, the insurer will pay to the provider an amount on account of the provider's GST liability in addition to the GST exclusive fee. Suppliers must provide the insurer with a tax invoice where the amounts are subject to GST.

For queries regarding whether the services you provide to a worker are taxable (that is, subject to GST) please contact the Australian Taxation Office and/or your tax advisor.

Appropriate tax invoices for private hospital patients are to be submitted to insurers (or if relevant, workers). Invoices must include the following **minimum** information:

- hospital name and address, provider details (i.e., treating practitioner) – name, Medicare provider number (if applicable) and/or insurer provider number (if known)
- invoice number and invoice date
- Australian Business Number (ABN)
- worker's surname and given name(s)
- date of birth (if known)
- claim number (if known)
- brief description of the injury to which the services relate
- employer name (if known)
- bank account details for electronic funds transfer (EFT)
- each service itemised separately in accordance with this fee schedule including:

For surgical procedures—

- o date of service
- o service item number and service description (including ICD10 code, surgery commencement and completion times)
- o theatre band corresponding to the service item number and description
- o charge for the service in accordance with this fee schedule

- each taxable sale must display the total charge and GST applicable
- where the invoice contains both taxable and non-taxable supplies that the taxable must be listed with the GST and total applicable for each individual supply
- a copy of the relevant operation note must accompany the surgery invoice.

For non-surgical inpatient admissions—

- date of service including admission
- service item number and service description
- charge for the service in accordance with this fee schedule
- each taxable sale must display the total charge and GST applicable
- where the invoice contains both taxable and non-taxable supplies that the taxable must be listed with the GST and total applicable for each individual supply.

It is important to note that some insurers may require additional information such as discharge dates on their invoices.

Invoices that do not meet these standards may be returned to the provider for amendment.

Invoices are to be submitted **within two months** after completion of the treatment as per section 213(2) of the [Workers' Compensation and Rehabilitation Act 2003](#).

Invoices received **more than two months after** completion of the treatment may not be paid unless in exceptional circumstances.

Insurers are unable to pay on 'account rendered' or statement invoices. Payment will be made, where appropriate, on an original invoice or duplicate / copy of the original.

Payment for services, including reports, will not be made in advance.

Where payment is outstanding

Please contact the insurer if:

- the claim has been accepted,
- prior approval for the hospitalisation was obtained, and
- the payment is outstanding (if greater than two months after completion of the treatment).

If the claim has not been accepted, responsibility for payment of accounts rests with the worker.

Additional information

The insurer may request additional information as evidence of the service provided and invoiced.

Quality assurance

Insurers may request a copy of the performance metrics relating to workers' compensation admissions.

The criteria for the performance metrics may be developed in consultation with the relevant private hospitals.

The objective of WorkCover or a self-insured employer under section 5 of the [Workers' Compensation and Rehabilitation Act 2003](#) is to ensure that workers receive timely treatment and rehabilitation to assist with their return to work.

This table of costs sets out the maximum fees payable by the insurer for the applicable services. This fee schedule applies to all work injury claims whether insured through WorkCover or a self-insured employer.



The maximum fees in this schedule apply to services provided on or after **1 December 2024**. The related injury may have been sustained before, on or after this date.

The purpose of the services in this fee schedule are to enable injured workers to receive timely and quality medical and rehabilitation services to maximise the worker's independent functioning and facilitate their return to work as soon as it is safe to do so. WorkCover or the self-insurer will periodically review a worker's treatment and services to ensure they remain reasonable having regard to the accepted work injury.

WorkCover expects the provision of services to be consistent with this fee schedule and to be reasonable. Systems are in place for monitoring compliance with invoicing and payment rules. Non-compliance with expected service provisions will be addressed with providers. Compliance actions may range from providing educational information to assist providers in understanding the expectations, to criminal penalties for fraud. WorkCover also reserves the right to refer misconduct to the relevant professional body, council, or complaints commission.

Maritime Safety Queensland
Brisbane, 19 November 2024

I, Kell Dillon, General Manager of Maritime Safety Queensland, pursuant to section 197 of the *Transport Operations (Marine Safety) Regulation 2016*, state that a person crossing a coastal bar (as defined in Schedule A) using a craft (that is defined in Schedule B) is an activity that endangers marine safety unless the person is wearing a lifejacket, with effect from 1 December 2024.

For this Notification of Danger to Marine Safety, a person is taken to be wearing a lifejacket if the person is wearing a lifejacket of a size and type appropriate for the person and the activity being undertaken.

1. Craft means a thing in the style of and with a risk profile of:
 - a) a small sail boat (funboat, laser, heron);
 - b) a pedal boat;
 - c) a raft, including an inflatable raft;
 - d) a rowboat (excluding a Surf Life Saving Australia Club Surfboat);
 - e) a sea or surf kayak.
2. Craft does not include a thing in the style of and with a risk profile of:
 - a) a body or boogie board;
 - b) a surf board;
 - c) a wind surfer;
 - d) a kite surfer;
 - e) a stand up paddle board.

SCHEDULE A – COASTAL BARS

Coastal bar has the meaning as defined in section 24(4) and Schedule 1 of the *Transport Operations (Marine Safety) Regulation 2016*. The coastal bars are named in column 1 and described in column 2 below.

Currumbin Bar	the bar located near the town of Currumbin in the vicinity of where the Currumbin Creek and the Coral Sea meet
Tallebudgera Bar	the bar located near the town of Burleigh Heads in the vicinity of where the Tallebudgera Creek and the Coral Sea meet
Gold Coast Seaway Bar	the passage of water between Nerang Head and Porpoise Point on South Stradbroke Island (commonly known as the Gold Coast Seaway)
Jumpinpin Bar	the passage of water between North Stradbroke Island and South Stradbroke Island
South Passage Bar	the passage of water between North Stradbroke Island and Moreton Island
Caloundra Bar	the bar located near the town of Caloundra in the vicinity of where the northern end of Pumicestone Channel (commonly known as Pumicestone Passage) and the Coral Sea meet
Mooloolah Bar	the bar located near Point Cartwright in the vicinity of where the Mooloolah River and the Coral Sea meet
Maroochy Bar	the bar located near the town of Maroochydore in the vicinity of where the Maroochy River and the Coral Sea meet
Noosa Bar	the bar located near the town of Noosa Heads in the vicinity of where the Noosa River and the Coral Sea meet
Wide Bay Bar	the bar located between the southern end of Fraser Island and Inskip Point in the vicinity of where the southern end of Great Sandy Strait and the Coral Sea meet
Round Hill Creek Bar	the bar located near the town of Seventeen Seventy in the vicinity of where Round Hill Creek and the Coral Sea meet
Cawarral Creek Bar	the bar located near the town of Keppel Sands in the vicinity of where the Cawarral Creek and the Coral Sea meet
